EXECUTIVE DIRECTOR – THE CANADIAN ACADEMY OF ENGINEERING (CAE) Summary of Duties and Responsibilities

The Executive Director reports to the Board of Directors of the Academy and has duties and responsibilities covering strategic planning, administration, finances, publications, scholarships, and external relations, all aimed to promote the objectives of the Academy as outlined in its Mission (see below). The Executive Director is supported by contracted services from Flagship Solutions which provides administrative, financial and organizational support for CAE events, the Fellowship nomination process, and other events as required.

General Aspects

Key aspects of the Executive Director position relate to managing the organization and implementing the Academy's strategic plans. Activities include:

- Maintaining positive relationship with Fellows of the CAE
- Organizing meetings of the Board of Directors, the Executive Committee, the Annual Meeting of Members, Standing and Ad Hoc Committees and the annual cycle of the admission of new Fellows to the Academy;
- Participation in identifying and managing of CAE's special projects;
- Representing the Academy with Federal officials and Parliamentarians and on joint committees with other organizations;
- Maintaining a healthy working relationship with other organizations in which the Academy has an interest (see below);
- Acting as an ex-officio member of all committees and joint committees of the Academy and prepares minutes or reports of meetings as required; and
- Ensuring the smooth operation of the Head Office including the hiring and supervising of contractors, other staff and keeping the necessary Academy records.

The Executive Director is also expected to take a lead role in identifying new partnerships and potential funding opportunities in support of the above.

Financial Responsibilities

Under the general guidance of the Chair of the Finance Committee, and with the support of a bookkeeper, the financial aspects of the Executive Director's duties include:

- Preparation of the annual budget;
- Investing endowment and other funds;
- Banking operations and acknowledgement of donations;
- Payment of invoices;
- Rent and other financial operations; and
- Preparing periodic financial reports for the Board.

Outreach

The Executive Director is responsible for developing, editing, printing distribution and web posting, as required, of Academy publications including:

- Regular newsletters
- Academy reports;
- Occasional reports and briefs to government;
- Members' database;
- Website and social media
 ensure that content is kept current and accurate;
- PowerPoint presentations of the Academy; and
- Surveys of Fellows conducted from time to time.

External Relations

In terms of external relations, the Executive Director is expected to promote the interest of the Academy and maintain a healthy relationship with other organizations in which the Academy has or may have an association including:

- The Council of Canadian Academies;
- Royal Society of Canada;
- Canadian Academy of Health Sciences;
- International Council of Academies of Engineering and Technological Sciences;
- Engineers Canada;
- Association of Consulting Engineers of Canada;
- Engineering Institute of Canada;
- Partnership Group for Science and Engineering; and
- Appropriate Federal Government Departments and Agencies such as Natural Sciences and Engineering Research Council, Innovation Science and Economic Development Canada, Natural Resources Canada etc.

Other duties may be assigned from time to time.

Qualifications

The ability to perform these duties will typically require at least 10 years' experience in progressive senior management roles and in the interaction with volunteer boards. Preferred candidates will be registered professional engineers. Bilingualism would be an asset.
