SCHEDULE A STATEMENT OF PURPOSE OF THE CORPORATION

The purposes of the corporation are as follows:

- 1. To provide means of anticipating and assessing the changing needs of Canada and the technical resources that can be and should be applied to them and to sponsor programs aimed at meeting these needs;
- 2. To provide independent and expert advice on matters of national importance pertinent to engineering;
- 3. To recognize outstanding contributions to society and to the country by leading Canadian engineers and to highlight exceptional engineering achievements;
- 4. To complement the role and functions of existing national engineering organizations and to cooperate with the Royal Society of Canada and other national bodies on matters involving both their respective fields and the field of engineering;
- 5. To cooperate with other national academies and international bodies on matters of mutual interest;
- 6. To serve the nation in connection with significant challenges involving engineering and technology; and
- 7. To do all such other things as are incidental or ancillary to the attainment of the above purposes.

SCHEDULE B

ADDITIONAL PROVISIONS

- 1. The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in furtherance of its purposes.
- Directors shall serve without remuneration, and no director shall directly or indirectly receive
 any profit from his or her position as such, provided that a director may be reimbursed for
 reasonable expenses incurred in the performance of his or her duties. A director shall not be
 prohibited from receiving compensation for services provided to the corporation in another
 capacity.
- 3. The directors may appoint one or more directors, who shall hold office for a term expiring not later than the close of the next annual general meeting of members, but the total number of directors so appointed may not exceed one-third of the number of directors elected at the previous annual general meeting of members.
